MINUTES OF THE MEETING held at 20:00 on Monday 16 January 2017 in Wellow Village Hall BA2 8PU

He had filled 275 bags with leaves, a record, with more to come.
One of the lime trees by the Church needed attention.
Cllr Chivers will inspect.

 Mike Clarkson outlined options being explored by the group holding vouchers to help improve very low broadband speeds. BT had finally come up with a proposal. Truespeed were due to confirm their proposal later that week. Elsewhere, Truespeed were providing 200Mbps broadband for £47pcm. They needed 75 properties to be able to proceed in Wellow.

The Chair thanked the speakers, closed Public Participation and opened the Parish Council meeting.

17.01 Apologies

Apologies for absence were received and accepted from Cllr M. Hartigan (work).

17.02 Interests

There were no declarations of interests.

17.03 Vacancy

There was no candidate to fill the vacancy for a councillor.

17.04 Minutes

17.06 Highways and Rights of Way

(a) Parking and speeding in Wellow

- Cllr Clarkson had sent Speedwatch information to Dean Brewis of the Avon and Somerset Speed Enforcement Unit. As a result she would be contacting motorcycle patrol officer Adrian Humphries.
- The Clerk to ask B & NES to fill a deep pothole at Wellow Trekking Centre and refresh worn out white lines/'Slow' signs generally.
- Councillors discussed parking on the pavements in Wellow Square. Cllr Clarkson asked if the notices put on car windscreens were too polite. Cllr Kotchie said white lining outside properties had to be paid for. Cllr Clarkson will investigate where bollards could be placed.
- Cllr Chivers suggested village 'gates' as at Hinton Charterhouse. B & NES to be asked to consider these.

17.09 Meeting the needs of the elderly

Feedback included

- Available transport options included the Fare Car (no age stipulation) and Swan Transport. Cllr Handel will publicize this in the *Parish Newsletter*.
- Cllr Chivers was working on a village directory to include the above information
- Cllr Andrews supported a directory of services, for all ages
- The Parlour Shop would be asked at its next meeting if it would consider deliveries to the elderly.

17.10 Village Hall

Cllr Andrews praised the new lighting on the driveway but noted that it could only be controlled from inside the Hall.

Cllr Betts (Chair, Village Hall Committee) will explore the possibility of installing sensors on the drive.

17.11 Royal Garden Party

It was agreed to nominate Cllr Chivers and her husband for the draw to attend the Royal Garden Party

17.12 Finance

(a) The Month 9 financial statement was received.

District Cllr Butters joined the meeting.

(b) The draft budget for financial year 2017/18 was considered line by line and adjustments made. Grants to parish bodies were pegged at current levels.

RESOLVED (proposed Cllr Kotchie, 2nd Cllr Chivers, unanimous) to set a balanced budget, with income of £15,083.

(c) **RESOLVED** (proposed Cllr Clarkson, 2nd Cllr Andrews, unanimous) to sign a precept for 2017/18 of £11,845.

It was noted that

- the increase from £11,310 in the current year takes account of the fact that B & NES has halved the council tax support grant to £310. The increase in precept would otherwise have been 1.99%.
- the charge for a Band D household is £49, average for rural parishes in the area.
