"You shall!" by Matthew Street, The Vicar, based on John 8:32; 10:10; Matthew 7:7

You shall know the truth, and the truth shall set you free. I have come so that you shall have life, and have it to the full. Ask and it shall be given to you; seek and you shall find; knock and the door shall be opened to you. (John 8:32; 10:10; Matthew 7:7)

'Don't do that!' 'Stop it!' 'Leave it alone!' There can be times when being a parent feels like constantly nagging, forever saying no. The same, sadly, is the impression some people have of the Church; a view reinforced by those old Wayside Pulpit posters you still sometimes see, starkly proclaiming 'The wages of sin is death' or some other equally cheery message! Undeniably, there is a negative element in the Bible, epitomised by the majority of the Ten Commandments with their stem preface: 'Thou shalt not ... '

This, however, is by no means the whole story, for in the teaching of Jesus the message is reversed. Instead of 'You shall not' it becomes 'You shall', all the negative commandments being summed up in one positive: 'A new commandment I give you: Love one another' (John 13:14). Repeatedly it is the same story: you shall have, you shall know, you shall find - the blind shall see, the lame walk, the imprisoned be set free, the pure in heart see God, the hungry and thirsty be satisfied, and so on and so on. Never think that being a Christian is about what you can't do, still less give that impression to others. Above all, it is about what you can do; about the possibilities the love of Christ opens up; about the sheer potential of life!

#### **Wellow Parish Council**

The Parish Council meeting took place on Monday 7th February in the village hall. The following discussions took place:

**Public Participation:** The Parish Sweeper reported that the drains in the village have been cleaned out well recently by BANES.

Inconsiderate parking in the village, especially in the vicinity of the school continues to be a problem for farm vehicles.

The Wellow groups' website, the wellow.org domain, is to be moved to a commercial server. The cost associated with this is not known at this stage. The parish council has been asked to provide the figures for consideration at next meeting.

Village car park: Joy riding late at night has been reported. The possible installation of obstructions at the entry was discussed.

Canteen Lane: A car accident, which caused a serious damage to a house on the

High Street was reported. Police was involved, but BANES need to respond to it too. A letter to BANES Highways Authorities will be sent by the parish council.

Canteen Lane: Parking, breaking a highway code and obstructing a clear sightline was reported.

**Parish Council Vacancy:** The Parish Council currently has one vacancy which now can be filled by co-option. If you would like to become a Councillor, please contact Clerk@wellowparishcouncil.org.uk

#### Planning application:

The following application were considered:

21/05700/FUL: Bubblers Dytch, High Street - The Parish Council will contact BANES officers for clarification regarding green belt regulations.

The following planning decisions by B&NES Council were noted:

21/03507/FUL: Parcel 2200 Norton Lane – Permitted 21/04865/ADCOU: Barn at Upper Hayes, Bath Hill – Refused 21/04973/FUL: Parcel 6100 Dunkerton Hill – Permitted

**Assets of Community Value:** A parish survey to gather the residents' view of the Fox and Badger Pub becoming a community asset is to be published in the Parish Post. The results of this survey will be reviewed and discussed at the next parish council meeting.

**Highways & Transport:** Wellow Parish Council received £250 grant from Ward Councillor Empowerment Fund towards the cost of the traffic survey. This traffic survey is to commence at the end of February 2022.

Community Speed Survey: No update at this time.

#### **Public Right Of Ways:**

BA25/1 rear of Ford Farm: BANES have informed the parish council that this Byway Open to All Traffic could not be changed to restricted access.

Byway Girts Lane: The continuing problem of fence wire being cut and walkers using the field instead of the path was discussed. Ways to discourage people were discussed.

Canteen Lane: Registration as a public footpath is to be updated at the next meeting.

**Cotswold Landscape Review:** The document is to be reviewed by the council members and comments formalise at a later stage.

**Climate Change:** The Environment Policy have been approved. The Policy is published in the parish council website and on the village noticeboard.

**Alternative Energy Evening:** Worried about increasing energy prices or your carbon footprint? Learn how your neighbours have made the switch from oil to more sustainable forms of heating and energy. Come along to the Village Hall on Monday 21st March at 7:30pm

**Bathavon Forum meeting:** Bathavon Forum is created to bring together local communities in BANES area to discuss current issues. Wellow Parish Council raised issues such as communication with BANES Planning officers, measures to reduce speeding in the village and Climate Change.

**Village car park.** Antisocial behaviour late evenings were reported. Possible measures to mitigate were discussed by the parish council members.

**Finance and Administration:** The potential options of the PC's communication systems and local websites were discussed. The costs will be considered at the next meeting.

#### Government response to the Landscapes Review consultation

The government is currently consulting on their response to the Landscapes Review, and it's an important issue to those of us living within the Cotswolds AONB. As the document is rather dense, I have summarised some key points below on behalf of the Parish Council.

Firstly, the Landscapes Review was carried out in 2019, led by Julian Glover. It's hard to summarise the summary further, but basically it called for AONBs like ours to become part of a joined up national service called National Landscapes, with greater funding, enhanced diversity of access, better governance, a strengthened role in responding to climate change and biodiversity loss, and better provision for the people who live and work within those landscapes.

The key points that seem to pertain to us falling within the Cotswolds AONB are:

The Landscape Review called for AONBs to have greater funding and statutory powers, to match the status of National Parks, and for all of these areas to be redesignated as National Landscapes, headed up by a new National Landscapes Service.

The government is proposing to more closely align the statutory purposes of National Parks and AONBs, and is considering the name change. They are not creating a new single entity, but are instead proposing that a national partnership for collaborative working be created out of the existing national parks, AONBs, and Natural England.

The government has created the Farming in Protected Landscapes (FiPL) programme which will provide funding to farmers and land managers to fund projects that:

- support nature recovery
- mitigate the impacts of climate change
- provide opportunities for people to discover, enjoy and understand the landscape and its cultural heritage

New environmental land management schemes are being developed and views are being sought in the current consultation.

Find us on Facebook @PestSolutionsSouthWest Expert pest solutions for over ten years The Landscapes Review proposed creating a new statutory purpose to foster the economic and community vitality of national landscapes. However the government proposes that existing statutory duties and responsibilities to consider the rural economy are enough, along with programmes like FiPL.

Regarding transport, the government thinks that protected landscapes like ours may require bespoke transport arrangements, and are updating guidance around Local Transport Plans.

A new charity is being formed under the National Trails umbrella to improve access to the natural environment. The Landscapes Review proposed expanding open access rights. The government instead proposes paying landowners for access and engagement, and remedying barriers to the provision of permissive access.

The government is proposing making a greater range of enforcement powers available to National Park authorities to deal with antisocial behaviour. It's not clear how this will impact AONBs.

The Landscapes Review proposed that AONB teams be given statutory consultee status for planning applications. The government is concerned about the resource implications of this on AONB teams, and is seeking views in the consultation on how AONB teams can achieve better outcomes in the planning process. The government intends to review the National Planning Policy Framework and consider policy for protected landscapes.

The Landscapes Review proposed a new, publicly funded housing authority specifically for national landscapes to address problems with affordable rural housing. The government essentially proposes that existing rural housing associations are enough.

The Landscapes Review proposed better funding of National Landscapes. The government proposes not to match the recommended increase, but to increase their core grant by 15%, and also to encourage pursuing private and commercial funding by selling the benefits of nature. To aid this, they propose broadening the legal competence of National Parks authorities to a more general and significant power, similar to local authorities. It's not clear whether this will impact AONBs.

There's quite a lot in the document, including a whole section on governance and board selection, and some thoughts on green lanes.
